CAREER SUMMARY

A Vocational Assessment and Rehabilitation specialist working in the field since 1990

- Employed as a Vocational Evaluator within the NHS.
 - Developed and managed a vocational assessment and rehabilitation centre for individuals with mental health problems.
 - Provided training on mental health and work on behalf of Employment Services.
 - Developed audit within a day services setting for clients with Learning Disabilities
 - Extensive experience of vocational assessment and the preparation of reports highlighting strengths and weaknesses, and identifying goals to be achieved if work is to be a realistic option.
 - Provided many expert witness reports in the field of personal injury since 1997. Prior to the Woolf Reforms, approximately 70% of my cases were on behalf of the Defendant, the remaining 30% being Claimant instructions. Since the Woolf reforms I have mainly received joint instructions (around 95%). These are initiated, on a roughly equal basis, by Claimant and Defendant Solicitors. I have given evidence in Court in the UK and South Africa
 - Case management activities and the co-ordination of vocational rehabilitation programmes to help the injured individual maximise their potential and begin the return to work process.

September 2007 to date: Self employment as a Rehabilitation Case Manager, providing reports for use in personal injury cases. I do both litigation and rehabilitation work. Based in South Yorkshire I work with individuals across the UK and have worked on international cases.
